AIMS AND SCOPE

(**TIJER**) is a publication of Oyo State College of Education, Lanlate that focuses on multidisciplinary studies covering Education, Humanities and Social Sciences, Languages, Vocational and Technical Education, Natural and Physical Sciences. It is a peer-reviewed journal that welcomes articles of interest from researchers not limited to above stated subject areas. However, the specific areas of coverage of the journal shall include the followings:

- 1. Research on language education, linguistics, literature and literary appreciation which delve on general application of languages that aid teaching and learning in different disciplines.
- 2. Research on advancement of man as a social being.
- 3. Research that injects effective contributions in the fields of applied sciences, innovation and technology as well as other similar academic areas.
- 4. Research that aids the teaching and learning of physical and natural science for the purpose of nation building.
- 5. Research in the areas of information acquisition, provision and dissemination for the advancement of frontiers of knowledge.

Editorial Policy

Trailblazer International Journal of Educational Research (**TIJER**) is bi-annual, published in April and August of every year. Submission of well researched articles implies an understanding that the paper has neither been published elsewhere nor accepted for publication in another journal. The copyright ownership of the journal lies with Oyo State College of Education, Lanlate while the views and opinions expressed in the articles are those of the authors or contributors. As a peer reviewed journal, articles submitted would be assessed by a minimum of three assessors and only those that meet the standards of the journal shall be published.

Guidelines for Manuscript Submission/Instructions for Authors

Any manuscript submitted for publication in this journal should be written in clear, lucid, concise and grammatically polished language which could be English, French, Arabic or any of Nigerian languages. Typing of the manuscripts should be doubled line space, in Times New Roman and in 12-font size. A paragraph should not be less than Three (3) sentences. Three copies of the manuscript should be submitted to the Editor-in-Chief for vetting or through electronic transmission as an attachment to the following addresses:

Presentation of the manuscripts

The manuscripts should be submitted not later than February and June for April and August editions respectively. This manuscript should follow the order of presentation as shown below:

Title of paper:

The title phrase should be brief and should consist of the title of the article, author(s) full names (First-Name, Middle-Name and Last Name) affiliations of the authors (Department and Institution), and their phone numbers and e-mails. Titles and qualifications of the authors are not required.

Abstract:

The abstract which should be informative should not exceed 250 – 300 words. It should be well structured to address the following basic elements:

- i. The research focus/objectives (i.e. statement of the problem(s) research issue(s) addressed and research objectives)
- ii. The research methods used (experimental research, case studies, method of analysis used, instruments used etc.)
- iii. The research findings/result; and
- iv. The main conclusions and recommendation/suggestions. For empirical papers, recommendations are accepted while suggestions are recognized for position papers.

Keywords

Keywords which should not be more than 5 should be provided below the abstract to assist in indexing of the article. These words should not duplicate key words from the article.

Abbreviations

Abbreviations should be defined for the first usage, and acronyms be used subsequently.

Introduction

The introduction should provide sufficient background information about the article. This should also include statement of the problem which should be stated in a clear and concise manner. It should not incure either the findings or conclusion. The research questions and hypothesis to be tested must be stated in a clear terms.

Methodology

This should be concise on how the research questions would be put to test and should be sufficient enough to allow for replication by other researchers. For review articles, this may not be necessary.

Results

Results should be presented for better interpretation of research findings.

Discussion of Findings

This should be separated from the result.

Tables and Figures

Tables and figures in research papers should be presented in a logical sequence and in 8-font size and be kept to the barest minimum. They should have a short descriptive title and be numbered consecutively using Arabic Numerals (1, 2, 3...n). These tables and figures should be organized in Microsoft Word or Excel Spreadsheet. Figure/Graphics should be prepared in GIF, TIFF, JPEG or PowerPoint and appropriately cited in the manuscript. Repetitive presentation of the same data in different forms should be avoided as much as possible.

Referencing

All sources consulted (either cited or not) must be listed. References should be listed in an alphabetical order at the end of the paper and should follow the latest edition of APA referencing style. DOIs, PubMed IDs and links to referenced articles should be stated where available.

Reference List

Journal Paper:

Author, A. A., Author, B. B., & Author, C. C. (Year of Publication). Article Title. Journal Title, Volume Number (Issue Number), Page Number Range. Retrieved from http://www.xxx (if online)

Chapter in Edited Book:

Author, A. A., & Author, B. B. (Year of Publication). Title of the Chapter or Entry. In A. Editor, B. Editor, & C. Editor (Eds.). Title of the Book. (page number range) Place of Publication: Publisher.

Books:

Author, A. A. (year of publication). Title of the book (Edition, if 2nd or later edition). Place of Publication: Publisher.

Conclusion

This should describe the extent to which the research questions have been answered.

Recommendation

Arising from the study, recommendations (for empirical papers) and suggestions (for position/opinion papers) for remediation of issues identified in the study should be given. It should be devoid of ambiguity.

Proofs

A vetted paper is sent back to the author for correction where necessary. Author of such paper is strictly implored to effect the correction and return the corrected version of the paper (with proof) for publication.

Publication

Upon receipt of the corrected paper, it would be published in the next issue of the journal.
